Halls Report for Willingham Parish Council, January 2015

The following activity with respect to Halls can be reported:

- 1. There is no activity of note to report with respect to the Public Hall.
- 2. Discussions about the leasing arrangement with Willingham Youth Trust (WYT) for the youth conversion have been ongoing. WYT have requested a lease based on the contents of a letter written by the Parish Council in January 2012. WYT argues that it would be irresponsible to do otherwise as their current level of funds is extremely low and the viability of hiring the building is, as yet, untested.

The January 2012 letter commits the Parish Council as follows:

'WPC will grant WYT a tenant repairing lease for 10 years at a peppercorn rent, renewable at WYT's option every 5 years thereafter as long as it is not materially in breach of the lease terms. WPC will continue to maintain the exterior of the building. The lease will not be assignable without the permission of WPC, but to raise funds WYT can offer the rooms for short term hire if they wish. The lease would terminate if WYT ceases to exist or use the building for a period to be agreed.'

A draft lease, incorporating the contents of the 2012 letter, will be circulated.
