# Minutes of the Planning Committee meeting held on 25 July 2012 at 7 30 pm in the Parish Office, Ploughman Hall, West Fen Road

## Apologies for absence

Apologies were received and accepted from Councillors Cook and Purnell due to Holiday

- 6(ii) All Councillors stated that they knew Mr Warren as the Postmaster for the Village but none had any prejudice on this application.

4. Minutes of the meeting held on 11 July 2012

Councillor Watson proposed these be accepted as a true record of the meeting. This was seconded by Councillor Jacques and agreed unanimously.

- 6. Planning applications for consideration
  - (i) S/1264/12/RM 178 Station Road, Willingham Mr M Wright Reserved matters application for access, appearance, landscaping, layout and scale of dwelling house

Councillor King proposed that Willingham Parish Council make no recommendation. However the Parish Council have noted the progressive development of this site and that of number 176 and do have concerns regarding the overall development. The Parish Council would ask that Highways are consulted to ensure any access concerns are addressed and would leave the decision and advice to SCDC. The Parish Council would also be reluctant for any further development to the site being approved. This was seconded by councillor Watson and agreed with four votes in favour and one abstention.

(ii) S/1373/12/AD - 9 High Street, Willingham - Mr C Warren - Illuminated Sign

Councillor King proposed that Willingham Parish Council recommend approval. This was seconded by Councillor Watson and agreed unanimously.

(iii) S/1476/12/VC – 2 Greenacres, Meadow Road, Willingham – Miss M Wenman – variation of condition 1 of application S/1719/09/F to allow permanent consent.

Councillor King proposed that Willingham Parish Council make no recommendation but would stress the following points:

Willingham Parish Council continue to be very concerned about the number of traveller sites in the village and feel that it is very important that sites are spread evenly across the District, the County and the Country. Having consulted in depth with the traveller community as well as the static population in the village this seems to be the preferred option by all parties.

However, in view of the somewhat surprising comments expressed by the inspector asked to look into the appeal for S/1561/09/F - Mr D Bibby, the council has to accept that some temporary consent will have to be made permanent.

Actions
