Minutes of the Planning Committee meeting held on 14 August 2012 at 7 30 pm in the Parish Office, Ploughman Hall, West Fen Road

1. Apologies for absence

Apologies were received and accepted from Councillors Purnell and Jacques

Public forum (maximum 3 minutes per person, with an overall limit of 15 minutes)
The meeting was adjourned.

In view of his role at SCDC Councillor Manning felt it correct to leave the meeting and not be a part of the discussion, he left the meeting at 7.40pm and did not return until after the application had been discussed and decided upon.

The public forum lasted for 30 minutes and a lengthy discussion took place, in summary:

Mr Buckley and his family came to speak with regards to their planning application 6(iii). Mr Buckley was very unhappy and stated that if the application was refused he would have to pull down his property and would be made homeless. Mr Buckley's daughter stated that her parents had lived in the village for a long time and had done everything correctly and received no complaints so they wanted to know why they hadn't been granted permanent consent. Ms Buckley also stated that she wanted to move her business fully to the Meadows. Ms Buckley went on to ask the Parish Council if they wanted to stop all travellers living in the village.

Councillor Pake stated that this was not the case and outlined the issue in Willingham with proportionality and Councillor King went on to explain that the Parish Council work very hard to be inclusive and consistent in their approach and have indeed sought the views of parishioners and travellers and incorporated them into the Parish Plan.

The meeting was reconvened:
