- 6. Planning applications for consideration
 - (i) S/2066/12/CA 49 Church Street, Willingham Mr A Cook Demolish existing front wall

Mr Cook is known to all councillors as he is the Chairman of the Council and a declaration of interest was noted and dispensation granted — as above. The application was assessed as it would have been for any other applicant.

Councillor Law proposed the Parish Council recommend approval as the plans were more in keeping with its surrounds. This was seconded by councillor Manning and agreed unanimously.

(ii) S/2065/12/FL - 49 Church Street, Willingham - Mr A Cook - replace existing wall and gate with iron gates and

(iv) S/2053/12/FL 178 Station Road, Willingham, Mr M Wright – retention of polytunnels and storage shed.

Councillor Law proposed the Parish Council recommend approval. This was seconded by councillor Pake and agreed unanimously.

(v) S/2096/12/FL - Land to rear of 94 Rampton Road, Willingham - Mr and Mrs Jones - dwelling

Councillor Watson proposed the Parish Council recommend refusal on the grounds of large background development with limited access which may set a precedent. This was seconded by councillor Manning and agreed with four votes in favour and one abstention.

(vi) S/2108/12/FL - 2 Station Road, Willingham - Mr Shilleto - extension.

Councillor Law proposed the Parish Council recommend approval. This was seconded by councillor Manning and agreed With four votes in favour and one abstention.

(vii) S/2011/12/VC - 12 Green Street, Willingham - Mr G Nelson, Relmfield Ltd - erection of 9 dwellings following the demolition of existing dwelling - variation of condition 2 (approved plans) of planning consent S/2285/10 to allow for re-siting of plots 1 and 2.

Councillor Manning proposed the Parish Council make no recommendation. This was seconded by councillor King and agreed unanimously.
