6. Planning applications for consideration

(i) S/2102/12/AD - Willingham House, 50 Church Street, Willingham, Nr Z Li CIMC Ltd - Sign

Councillor Cook proposed that the Parish Council recommend approval. This was seconded by Councillor Harris and agreed unanimously.

(ii) S/0164/13/FL - 16 Saxon Way, Willingham, Mr and Mrs Moyes - single storey extension to front of house

Councillor Harris proposed that the Parish Council recommend approval. This was seconded by Councillor Law and agreed with five votes in favour and one abstention.

(iii) S/2532/12/FL - 8 High Street, Willingham, Mr S Andrews - Detached Dwelling

Councillor Watson proposed that the Parish Council recommend refusal as there was no evidence for the provision of visibility splays and in addition the width of the access is potentially dangerous when exiting onto the bend. This was seconded by Councillor Harris and agreed unanimously.

(iv) S/0182/13/FL - 19 Rockmill End, Willingham, Mr and Mrs Diogenous - ground floor extension to house

Councillor Law proposed that the Parish Council recommend approval. This was seconded by Councillor Harris and agreed with four votes in favour and two abstentions.
