Item 14 — Councillor Watson requested the minute be changed as he felt the minute "his failure to deliver the statement on behalf of the Parish Council" was incorrect. Councillor Cook felt very strongly that the minute was correct and the statement had not been delivered as had been requested.

Some discussion took place and Councillor Watson requested the whole issue be returned to full council for discussion as he was still not happy to accept the minute.

Councillor King strongly objected to this request, as he believed the minute to be fair and accurate and the objection spurious.

Subject to the above, Councillor Law recommended the minutes be accepted as a true record of the meeting. This was seconded by Councillor Harris and agreed with five votes in favour and three abstentions (two due to not being at the meeting)

6. Planning applications for consideration

(i) S/0825/13/FL – Alwyns Park, Willingham Road, Over, Mr P Pickering – change of use of land to gypsy and traveller site (3 pitches)

Councillor King proposed the Parish Council recommend refusal on the grounds of proportionality. Willingham has more pitches already than they can easily absorb and although the land is technically in Over it will most probably be Willingham Services that will be used and put under additional pressure. This has also previously been refused at appeal in 2008. This was seconded by Councillor Harris and agreed with seven votes in favour and one abstention.

(ii) S/0858/13/FL – 3 Rose and Crown Yard, Willingham, Mr Glen James – extension to dwelling (Councillor Harris took NO part in the discussions on this plan)

Councillor Law proposed the Parish Council recommended approval. This was seconded by Councillor Jacques and agreed with seven votes in favour and one abstention (due to declaration of interest).

(iii) S/1071/13/FL - 2 Pyrethrum Way, Willingham - Mr and Mrs A Riddell - single storey rear extension

Councillor Law proposed that the Parish Council recommend approval. This was seconded by Councillor Pake and agreed unanimously
