# Minutes of the Planning Committee meeting held on Wednesday 21 August 2013 at 7 30 pm in the Parish Office, Ploughman Hall, West Fen Road, Willingham

4. Minutes of the meeting held on 31 July 2013

Item 14 – Parish Forum update – this should read Parish Planning Forum Update. Subject to this alteration, Councillor Watson proposed the minutes be accepted as a true record of the meeting, seconded by Councillor Harris and agreed with 3 votes in favour and 3 abstentions due to not being at the meeting.

## 6. Planning applications for consideration

 (i) S/1476/13/LD – The Oaks, Meadow Road, Willingham, Mr T Buckley – use of building as dwelling, lawful development certificate.

Councillor Harris proposed that the Parish Council refer back to the previous decisions which were based on this being a mobile home and as the structure has not changed since then would make no further recommendations. This was seconded by councillor King and **agreed** with five votes in favour and one abstention.

(ii) S/1654/13/FL - 4 Pound Lane, Willingham, Mr and Mrs J Munns - extension to dwelling.

Councillor Manning proposed that the Parish Council recommend approval. This was seconded by Councillor Jacques and agreed unanimously.

(iii) S/1565/13/FL - 15 Green Street, Willingham Mr and Mrs Oviatt-Ham - construction of a house and garage

Councillor King proposed that the Parish Council make no recommendation. This was seconded by councillor Law and agreed unanimously.

#### 7. Applications for Tree Works

(i) 10 George Street, Willingham, - Mr and Mrs Burkitt - reduction in weight and crown of Birch tree 15%, fell and grind stump of Robina Frisia. Fell and grind stump of dying Sorbus. Fell and treat young Ash in neighbours garden.

Councillor Law proposed that the Parish Council recommend approval. This was seconded by Councillor Harris and agreed unanimously.

(ii) 36a Church Street, Willingham, - Luvu Properties - Fell Ash to ground level

Councillor Manning proposed the Parish Council make no recommendation but refer back to Roz Richardson for expert advice as to whether there is justification for its removal. This was seconded by Councillor King and agreed unanimously.

#### 10. Local Plan Update

Councillor King had looked through the plan and reported back to the Council. He had concerns regarding the reserved land for Northstowe. It was agreed at the Full Parish Council meeting on 7<sup>th</sup> August to write to SCDC to obtain clarification of exactly where the reserved land would sit. The Clerk has written to SCDC and is awaiting a response.

# 11. Update on CIL Charging structure

As requested, the Clerk has written to SCDC regarding comparison figures for CIL and S106 monies. SCDC have acknowledged receipt and are anticipating responding within the next 7 days or so.

The next meeting will be in October. Councillors Harris and Law attended Longstanton Parish Council meeting as SCDC attended to give a short presentation on the Northstowe boundary review. There was nothing significant to report at this stage.
