Minutes of the Planning Committee meeting held on Monday 16 March 2015 at 7.30 pm in the Parish Office, Ploughman Hall, West Fen Road, Willingham

1. To receive apologies for absence

ACTIONS

Apologies were received and accepted from Councillors Law and King both with prior commitments

2. Declarations of interest

Item 6(ii) Councillor Cook declared an interest as he knows the neighbours of the applicant Item 6(v) Councillor Cook declared an interest as he lives opposite the property.

3. Public forum (maximum 3 minutes per person, with an overall limit of 15 minutes) All parishioners wishing to speak and who are on the Electoral register, must make their name known to the Clerk prior to commencement of the meeting. Maximum of five people to speak. Large groups will need to decide on a spokesperson representative

None of the members of the public in attendance wished to speak.

4. To approve the minutes of the meeting held on 23 February 2015

Councillor Slater proposed the minutes be accepted as a true record of the meeting, seconded by Councillor Jacques and agreed with three votes in favour and three abstentions due to not being at the meeting

5. To deal with any matters arising from the minutes of the meeting held on 23 February 2015, not covered elsewhere on this agenda

6. Planning Applications for consideration

(i) S/0527/15/FL - 16 Rook Grove, Willingham - Mr T Henshaw - single storey rear extension

Councillor Manning proposed that the Parish Council recommend approval seconded by Councillor Slater and agreed unanimously.

(ii) S/0477/15/FL – 46B Church Street, Willingham – Mrs K Partridge – single storey rear extension and loft conversion including rear dormer window.

Councillor Manning proposed that the Parish Council recommend approval seconded by Councillor Harris and agreed with five votes in favour and one abstention due to declaration of interest

(iii) S/0508/15/FL - 76, High Street, Willingham, W Hopkins - Proposed Dwelling

The meeting was adjourned to ask the applicant questions in relation to the application.

The applicant confirm he had spoken to SCDC regarding the access being moved to Over Road and was happy for this to be the case.

The meeting was reconvened

Councillor Watson proposed that the council recommend refusal, no seconder was forthcoming and the proposal was NOT carried. Councillor Cook proposed the council recommend approval providing the existing access is permanently blocked up <u>prior</u> to building work commencing and that the ditch is not covered any further without advice from the appropriate officers at SCDC. This was seconded by Councillor Manning and **agreed** with five votes in favour and one objection.

Haw 2015-a-14

(iv) S/0351/15/FL – 47 Fen End, Willingham, Mr N Cartwright – single storey extension and loft conversion with dormer windows.

Councillor Manning proposed the Council recommend approval, seconded by Councillor Harris and agreed unanimously.

(v) S/0155/15/FL – 62 Church Street, Willingham, T Hill – barn conversion and link to existing dwelling for additional accommodation.

Councillor Manning proposed the Council recommend refusal as the linkage will result in insufficient parking and access to the back-land. The council would have no objection to the conversion of the barn as a stand-alone development. This was seconded by Councillor Slater and agreed with four votes in favour and two abstentions.

(vi) S/2025/14/FL - 24 Over Road, Willingham, Mr C Hill - erection of side extension.

Councillor Harris proposed the council recommend approval, seconded by Councillor Jacques and agreed unanimously

7. Lawful Development Certificates (for information only)

(i) S/0277/15/LD – Land to the East of Grange Park, 24 Priest Lane, Willingham, Mr T Browning – lawful development certificate for existing use of the land for residential purposes as a gypsy and traveller site.
