6. Planning Applications for consideration

(i) S/1212/15/FL – Land to the West of Haden Way, Willingham, Kerley & Co – erection of dwelling house and garage occupied by employee of Kerley & Co with access via Haden Way.

Councillor Law proposed the Council recommend approval, seconded by Councillor Manning and **agreed** unanimously.

(ii) S/2011/14/OL – Land to East of B1050 and Longstanton, West of Cambridgeshire Guided Busway (CGB) and North of Oakington – Mr P Kitson, Homes & Communities Agency – Development of Phase 2 of Northstowe with details of appearance, landscaping, layout, scale and access reserved (save for matters submitted in respect of the Southern Access Road (West) comprising (1)Development of the main Phase 2 development area for up to 3,500 dwellings, two primary schools, secondary school, t town centre including employment uses, formal and informal recreational space and landscaped areas, eastern sports hub, remainder of the western sports hub (to complete the provision delivered at Phase 1), busway, a primary road to link to the southern access, construction haul route, engineering and infrastructure works; and (2) construction of a highway link (Southern Access Road (West) between the proposed new town of Northstowe and the B1050, improvements to the B1050 and associated landscaping and drainage.

Councillor King proposed the Council make no recommendation, seconded by Councillor Slater and **agreed** unanimously.

(iii) S/1055/15/FL – 25 Berrycroft, Willingham – Mr and Mrs Thomson – garage conversion, insertion of dormer window to rear elevation and single storey side extension.

Councillor Law proposed the Council recommend approval, seconded by Councillor King and agreed unanimously.

(iv) S/1095/15/AD – Willingham Tabernacle Baptist Church, George Street, Willingham – Willingham Baptist Church – Advertisement.

Councillor Manning proposed the Council recommend approval, seconded by Councillor King with two votes in favour and three against. **Proposal not carried.**

Councillor Law proposed the Council recommend refusal due to the sign being illuminated in a conservation area, seconded by Councillor Watson and agreed with three votes in favour and two against.
