- 6. Planning Applications for consideration
- (i) S/0121/16/FL The Oaks, Meadow Road, Willingham Mr T Buckley retrospective authorisation of the residential use of the chalet building.

Councillor Cook proposed that the Council recommend refusal on the grounds that there is a history of temporary permissions on the site and the Council believe that this dwelling was part and parcel of those applications. The Parish Council have always opposed and continue to do so, all development to the North of Meadow Road, which is in the green belt as confirmed by the Planning Inspector at a previous hearing. This was seconded by Councillor Harris and agreed with five votes in favour and one abstention.

 To receive notice of SCDC planning appeal for S/1/48/15/Ft – 22 Fen End, Willingham, Mr D I Bowyer – erection of two storey dwelling.

Notice had been received that the appeal would be heard by way of written representation. Any comments were to be submitted by the 4 April 2016. The Committee agreed to make no further comments.

(ii) To receive and consider correspondence from Tree Warden re S/2833/15/OL – land adj to 30 Rockmill End/Meadow Road

The Tree Warden had submitted a report regarding the impact of the development on nearby arboriculture. It was agreed to forward the report to both SCDC and the developers of the site

(iii) To receive correspondence regarding the Long Lane Development

The Clerk had passed on a complaint to SCDC regarding mud left on the road by developers. SCDC had investigated and found there to be no problem at the time of visiting.

(iv) To receive and consider correspondence from SCDC regarding street furniture to the front of the public hall on the High Street.

The Clerk had contacted SCDC to ascertain what permissions would be required to add bollards to the front of the public hall. SCDC confirmed that such works would be carried out under GPDO – part 12 class A permitted development but Highways should be consulted to ensure it does not encroach on their land or cause a traffic hazard.
