To receive apologies for absence

Apologies were received from Councillor Cook due to being unwell and Councillor Harris due to a work commitment.

Councillor King proposed the minutes be accepted as an accurate record of the meeting, seconded by Councillor Croucher and agreed unanimously.

6. To receive an update from SCDC on the role of the Housing Development Agency. Councillor Harford was unable to attend so it was agreed to arrange another session at a later date.

7. To receive a presentation from SCDC regarding neighbourhood planning.

Councillor Robert Turner (Planning Portfolio Holder) presented neighbourhood planning to the committee and summarised the purpose of them. He confirmed that the Neighbourhood Plan (NP) must not be in conflict with the Local Plan and can give the Parish a stronger say in the type and location of development within the parish. The NP can be a lengthy process (averages 2 years) and can cost approximately between £30,000 and £40,000. Grants of

Concerns were raised that although Willingham is classified as a minor rural area large development applications are being received. Councillor Turner confirmed that once the Local Plan had been approved this would no longer be the case and development would be limited to that agreed for a minor rural area.

Councillor Turner agreed to speak to officers to ensure that the Parish Council are notified of any developments as soon as an application is considered at pre-application stage as this was not always happening.
