Planning Applications for consideration

(i) S/3238/16/OL - Land parcel adjacent Highgate Farm, Willingham Road, Over, Mr Papworth outline planning permission for a two-storey dwelling and access with some matters reserved.

Councillor Law proposed the Council recommend approval, seconded by Councillor Manning and agreed unanimously.

(ii) S/3174/16/RM - Parcel H4 - Phase 1 Northstowe, Bovis Homes Ltd - approval of reserved matters (access appearance, landscaping, layout and scale) for the erection of 84 new build dwellings with associated parking, landscaping and infrastructure following outline planning approval S/0388/12/OL

Councillor Harris proposed the Council recommend approval, seconded by Councillor Law and agreed unanimously.

(iii) S/3388/16/FL - 7 Priest Lane, Willingham, Mr J Price - proposed single storey extension

Councillor Law proposed the Council recommend approval, seconded by Councillor Slater and agreed with six votes in favour and one abstention (due to declaration of interest)

(iv) S/3378/16/FL - 63 Haden Way, Willingham, Mr Flack - single storey outbuilding to form a granny annex to the rear of the property.

Councillor Manning proposed the Council recommend refusal as the weatherboarding was out of keeping with the brick built building and although the development is described as a granny annexe it would appear to be a completely separate building. This was seconded by Councillor Croucher and agreed with four votes in favour and two abstentions.

Councillor Law left the meeting and Councillor Harris took over the Chair

(i) S/3229/16/TC – 5 Green Street, Willingham, Mrs Knighton – removal of Robinia due to outgrowing its location due to close proximity to the house.
