Councillor Anderson proposed the minutes be accepted as a true record of the meeting, seconded by councillor Harris and agreed with six votes in favour and one abstention due to not being at the meeting.

6. Applications for consideration

(i) S/0084/18/OL - Rear of 158 Station Road, Willingham, Mr S Parker - outline planning permission with all matters reserved for the erection of a two-storey dwelling.

Councillors Manning and Anderson left the room

Councillor Harris proposed the Council recommend refusal with the following comments:

- Back land development is not welcomed as it would create a precedent on this section of
- There are concerns about layout and density
- The Council noted and accepted Highway's concerns especially with respect to access
- It was unclear whether the access is shared with S/2620/16/OL?

This was seconded by Councillor Law and agreed unanimously

(ii) S/0116/18/OL - Land adjacent to 158 Station Road, Willingham, Mr S Parker - outline planning application with all matters reserved for the erection of a two-storey dwelling.

Councillor Harris proposed the Council make no recommendation with the following comment:

The application provided inadequate information especially regarding access.

This was seconded by Councillor Carlton and agreed unanimously.

Councillors Manning and Anderson returned to the room.

- (iii) S/4511/17/FL 8 Westfield, Willingham, Mr R Stewart two storey side extension and single storey rear/side extension.
- Councillor Manning recommended approval, seconded by Councillor Carlton and agreed unanimously.

- (iv) <u>S/4327/17/FL 1 Conference Close, Willingham, Mr & Mrs Mills single storey rear extension.</u> Councillor King proposed the Council recommend approval, seconded by Councillor Law and **agreed** unanimously.
- (v) <u>S/0122/18/RM Land off Rockmill end & Meadow Road, Willingham, Kier Cross Keys Dev LLP reserved matters application for 72 residential dwellings, including parking, public open space, local equipped area for play, pumping station, swale, landscaping and associated infrastructure, pursuant to outline planning application.</u>

Councillor Harris proposed the Council recommend approval and acknowledged that much thought and hard work had been given to the application. This was seconded by Councillor Anderson and agreed with six votes in favour and one objection.
