## 6. Applications for consideration

- (i) <u>S/1175/18/PA Land at Rampton Road, Willingham M Oviatt-Ham prior approval for a proposed change of for conversion of existing horticultural building to residential</u>

  Councillor Harris proposed that the Council object to the application as it is well outside the village envelope, seconded by Councillor Carlton and **agreed** unanimously.
- (ii) S/0583/18/OL 145 Station Road, Willingham Mr J Anderson outline permission for conversion and extension of existing workshop to dwelling

Councillor Manning proposed that as the applicant is a Parish Councillor, the Council make no recommendation and defer the decision to SCDC, seconded by Councillor Law and **agreed** unanimously.

- (iii) S/0726/18/FL unit 14, Highgate farm, Over Road, Willingham, Mr Papworth change of use from agricultural unit to class D2 (assembly & leisure) for the provision of a gym.

  Councillor Law proposed the Council support the application, seconded by Councillor Carlton and agreed
- unanimously.
- (iv) <u>S/1221/18/FL 13a High Street, Willingham Mr Yasim to extend ground floor into the rear</u> garden.

Councillor Manning proposed the Council make no recommendation, seconded by Councillor Harris and agreed unanimously.
