Minutes of the Planning Committee meeting held on 3rd July 2018 at 7.30 pm in the Parish Office, Ploughman Hall, West Fen Road, Willingham

9. To consider future \$106 funding allocations

Following discussion the committee proposed the following for recommendation to full Council at their meeting on the 4th July:

Projects to be allocated from existing \$106 monies

- Footpath to Community Orchard Brickhills monies (£36,123.46)
- Footpath to Highgate Rockmill End (£12,362) and Whites Path (£8,399.55) monies
- Meadow Road Improvements remainder of existing open space monies: Long Lane (£5,104.06), R/O Rampton Road (£3,475.84)

This would mean all current open space monies would be allocated and would leave the following existing monies to spend on Community Facility:

- Whites Path: £1,1339.04

31 Long Lane: £843.51

r/o 94 Rampton Road: £574.43

 Aspinalls: £6,585.70 (this is ringfenced for improvements and future maintenance of security measures and access at the Ploughman Hall)

Projects in order of priority from future S106 monies

- Ploughman Hall extension for storage
- Ploughman Hall improvements to heating and lighting

It was agreed that once full Council has ratified its project list and allocations a detailed and fully costed proposal for each project would be put together.
