- (i) S/0864/19/PA Land at Fox Corner, Rampton Road, Rampton, Mr Dino Prior approval for a proposed change of use of agricultural building to a dwelling house and for associated operational development.

Councillor Manning proposed the Council make no recommendation, seconded by Councillor Law and agreed unanimously.

(ii) S/0065/19/CM – Land at Needingworth Quarry, off B1050 Shelford Road, Willingham – visitor carpark and access road improvements.

Councillor Manning proposed the Council object to the application as the Shelford Road is inadequate to manage the number of vehicle movements (potentially an additional 50,000 per year) and the application is premature ahead of the issues with the road being rectified. The Council were also concerned that the number of expected visitors may also result in additional litter in the countryside. This was seconded by Councillor Croucher and agreed unanimously.

(iii) S/0820/19/LD – 13 Fen End, Willingham, Mr Tucker – certificate of lawful development for a single storey rear extension.

Councillor Manning proposed the Council make no recommendation, seconded by Councillor Law and agreed unanimously.

(iv) S/0834/19/RM -132 Rampton Road, Willingham – approval of matters reserved for appearance following outline planning permission S/0771/17/OL and S/4413/18/RM for detached dwelling with ancillary access and parking.
