Leisure and Amenities Report – August 2019

'Children playing' signs on West Fen Road

Following concerns raised by parishioners, the council agreed that one of its priorities for an A14 Legacy Grant application should be white 'gates' across parts of the verges on each side of the road, between the pavilion and the QEII field, with 'children playing' signs attached. This was subsequently withdrawn as not being suitable for that scheme, and it was suggested that the Parish Council look at funding it themselves. We have now been told by Cambridgeshire Highways that the white gates will not be allowed, and that we can apply for a Privately Funded Highways Improvement for the signs. This is currently being explored.

Pavilion walls

The Pavilion walls require repair to the rendering and re-painting but it has not been possible to identify the exact type of anti-graffiti paint currently on the walls, and therefore the type of paint which would be able to cover it successfully. This issue has been going backwards and forwards with contractors for some time now and we have taken advice from British Coatings Federation who have recommended testing a small area.

One of the potential contractors, Mark Tickner, has offered to do a patch test on the wall to help identify a suitable paint to use on the building. His quotation for this patch test is £200 plus VAT.

This £200 expenditure was approved on 30 July following a 'round robin' to all councillors.

Emergency plumbing work.

There was a problem with the flushing mechanism of one of the toilets in the pavilion. ACA plumbing attended at short notice and found that an inlet valve needed to be replaced, at a cost of £65.84
