Councillor Harris proposed the Council support the application but would ask Highways to check that the volume of traffic entering onto West Fen Road will not be problematic, seconded by Councillor Law, and **agreed** with three votes in favour and two votes against.

Councillor Harris proposed the Council make no recommendation. This was seconded by Councillor Watson and **agreed** with four votes in favour and one abstention due to declaration of interest.
