- (i) 21/01208/PRIO3C 27 Green Street, Willingham, Mr X Qian prior approval for a change of use from a craft shop (class A1/A2) to a small restaurant with small part of takeaway (class A3)
- (ii) 21/00811/HFUL 19 Rockmill End, willingham, Mr J Clements two storey side & single rear & side extension.
- (iii) 21/00850/HFUL 38 Over Road, Willingham, Mr O Chambers demolition of existing conservatory & construction of side and first floor extension over existing dining room & part former conservatory.
- (iv) 20/04039/CONDA 130 Rampton Road, Willingham, Mr S Webster non material amendment of planning permission 20/04309/S73 to extend the combined lounge, kitchen dining room by approx. 1.5m, remove some windows and make size changes to others and change one window for a door and change one door for a window.
- (v) 21/0418/TTCA 28 Church Street, Willingham Tree works T1 purple leaf plum reprune, equating to overall reduction of 2ms regrowth. T2 Silver Birch tip end reduce multiple regrowth leaders by 2 to 3ms and laterals by 1.5 to 2ms to rebalance crown. T3 Walnut raise crown to 3ms gardenside and tip end reduce remaining crown by 1 to 1.5ms to rebalance.
- (vi) 21/0476/TTCA 25 Church Street, Willingham T1 Yew, reduce the height by 2m and the spread in all directions by 1.5m.

(vii) 21/0428/TTPO - 6 Lacks Yard, Willingham – TPO 0001(1999) T1: Walnut (T1) – crown reduction by 3m from height and 1.5m from sides. This tree has previously been topped & lopped but now needs a reduction of the regrowth due to its proximity to the house. There is also a very large cavity at its base where a secondary stem was removed. The cavity has standing water at ground level, extends into the tree by 500mm and up the truck by more than 600mm.

(i) S/0218/19/NMA1 – 77 Station Road, Willingham - Non material amendment of planning permission S/0218/19/FL (Two storey side and single storey rear extensions) to change to brick, rather than block and render, bedroom 4 (front) window moved over so it is the same distance from existing house as the downstairs utility window, Increase size of Utility window to match Bedroom 4 window, Bedroom 1 window (rear) increased in height.
