2. Declarations of interest

6. Planning Applications for consideration

(i) 21/00915/REM - Land to the rear of 1B Over Road Willingham -: Reserved matters application for the approval of details of appearance, landscaping, layout, and scale following outline planning permission S/2921/15/OL (Erection of 26 Dwellings including 10 Affordable Units & Ancillary Access Arrangements (All matters reserved apart from access)). The outline planning application did not seek permission for EIA Development.

Councillor Harris proposed that the Council object to the application for the following reasons, seconded by Councillor Todd and **ratified** unanimously

As previously raised the Council has various concerns that have still not been addressed:

Not all conditions have been met in particular in relation to flooding concerns and surface water drainage issues. Although these have been approved by the SCDC officer, the Lead Local Flood Authority and Anglian Water have not approved the application due to inadequate/no drainage information being provided by the applicant.

The Council would continue to request assurance from SCDC that there is adequate soakaway provision for the site. Previous flooding in the village would indicate that the drainage system appears to be under excessive pressure and as a consequence the Council would not want any new developments to add to that system and potentially add to the flooding issues the village has experienced.

(ii) <u>257697 – Premises License Variation – Willingham Auctions Ltd, 25 High Street, Willingham – application to supply of alcohol, late night refreshment, hours premises open to the public.</u>
Councillor McKee proposed the Council support the application, seconded by Councillor Law, and **ratified** unanimously.
