Councillor Harris proposed the Council object to the planning application due to the following reason:-Although the Council are not technically qualified to understand the revised BNG metric and assessment, the Council cannot understand how the proposal will be more environmentally gainful than the existing site.

This was seconded by Councillor Law and **ratified** unanimously.

(ii) <u>24/03765/FUL – West Fen Farms, West Fen Road, Willingham, Cambridgeshire – construction of 2 No. agricultural buildings</u> Councillor Hutchcraft proposed the Council make no recommendation. This was seconded by Councillor McKee and **ratified** unanimously.
