- (i) 24/04329/OUT Oakhurst Station Road Longstanton Cambridgeshire Outline Planning Consent for the proposed demolition of the existing B8 storage and distribution buildings and the erection of two self-build/custom build dwellings Mr And Mrs Andrew And Mary Coe

Councillor Harris proposed the Council recommend refusal for this application based on the following reasons:-

- 1. The application was for back-land development
- 2. The application was for development between Willingham and Northstowe and whilst the Council acknowledge that some development has taken place in this area, they have always insisted that a clear boundary should be retained between the two areas.
- 3. The Council believed approval of the application would set a precedent for future similar developments.

This was seconded by Councillor Watson and ratified with five votes in favour and one against.
